Dear Parent/Carer

National Education Union - strike action for teachers.

As you may have seen, the National Education Union (NEU) confirmed that their teaching members will be taking industrial action in the form of strike days. The next scheduled dates are **Thursday 27th April and Tuesday 2nd May**.

This action is not against Outwood Academy Hasland Hall itself but is part of national industrial action organised by the trade unions about salary negotiations with the Department for Education.

Neither the Outwood Grange Academies Trust Board nor myself as Principal are legally allowed to close the academy in sympathy with the strike, and we will not do so. However, our main concern is the health and safety of our students. The academy will only close (partially or fully) if, in our opinion and following a full risk assessment, it is not safe to remain open.

Due to the number of staff taking action, **we have made the difficult decision to partially close the academy on Thursday 27th April and Tuesday 2nd May to most students in Years 7, 8, 9 and 10**, with the exception of any vulnerable students who will be expected to attend as normal. We will notify individual families directly if their children are expected to attend as a vulnerable student. The same criteria will be used as for the last strike days.

The academy will be open as normal to all year 11 students and students classed as vulnerable and should arrive for the usual 8.25 am start.

Whilst the academy will be closed to some students, online learning via Google Classroom will be available to all students and students will be expected to complete the work set.

Students in all year groups in receipt of free school meals will be able to collect a grab bag from reception between 12.30 to 1pm for their lunch.

In order to ensure that we can communicate any changes to these plans at short notice; which may include on the day itself, we are asking parents/carers to ensure that we hold up to date emergency contact details. If you do need to make any changes, please send to our dedicated email address for this purpose enquires@haslandhall.outwood.com. We will always endeavour to minimise disruption as much as possible.

We understand that there will be concerns about the disruption but we want to give you this advance notice and thank you in advance for your patience and understanding at this time.
